Long before he came to Braniford, Harry was a headline in the sports pages of the Turner's Falls home town paper and the dailies of outside cities. The stubby Frenchman excelled in all fields of sport and his name was revered by the school kids of the Massachusetts borough

his name was revered by the school kids of the Masserhauster bording and feared among the other schools of the state. Ray Pinkham, Superintendent of Schools here and a former Mass. schoolboy, who lived over thirty-five miles from Turner's Falls recalls the magic of Brazeau's cognomen. "He was halled with the same rever-ence as was Harry Williams," Pinkham marvels as the years unfold w carefree schooldays and supporting memories. "He played any position in basketball, football, baseball and per-formed with the nonchalant case which marks the true athlete."

It was natural then that he would be widely sought after as an

athlete by colleges throughout the country. With other friends and more he made at prep school, the lad had the world for his ovster. He attended four different'schools and player athletics at all of them. He became a tramp athlete in the true sense of the word. But for

meanderings about the country were cherished bits

snatchies of amusing pitter-patter, the five foot ten athlete never dwelt n the mechanics of war. It was only natural that he turn to Community service when the


