# Six Attending Fire Fighting School In City

Six members of the East Haven Fire Department are scheduled tomorrow to complete a week long course in fire fighting conducted by the state in cooperation with Fire Chief Paul Heinz of the New Haven department. Fire Chlef Thomas J. Hayes released a list of the names of the men who are attending the day-time intensive training being given at the State Firemen's Traning School under New Haven Batalion Chief Andrew Flanagan.

The men, all of the rank of fireman, are: Walter Wyllie, Ed-ward Buechele, Elmer Brainard, Daniel Carroll, Charles Fallon and John Covert. In addition to going to , school days, each has put in two nights of work in the local department to keep the per sonnel strength at a safe level. Two volunteers, Frank Andres of Company one and William Jacckson of Company six were put on duty as substitute fire men in the absence of the train ees.

In the course of training the men have received instruction in the laying of hose line and the use of regular water ad fog hoses. They have been taught technl-ques in fighting tank car fire and pit fires and have received training in the use of gas masks under actual conditions of heat and smoke inside a building. The course began Monday.
