



There have that been other somewhat similar cases reported from other cities within the last few months:

What conclusions, if any, should be wn? The causes of violent anti-social be havior are infinitely more complex, certainly, than the "dead-end kids" theory alone. One cannot ignore the possibility of those strange emotional aberrations, examples of which do the history of crime. But to say these recent atrocities prove crime has no attackable causes, that environment and associations pla no part, would be to afgue that parents might with clear consciences, "put the little beggars out into the street and be off to the bridge

The questions to be asked, rather, are How many delinquents come from good homes, conscientious parents, wholesome rec reational outlets, and socially normal companionships? And how many come from squalid neighborhoods, "broken" homes, inadequate outlets for play, and contact with delinguents and delinguent. behavior? The answers are plain.
