CONSTABLES

During the years prior to the 1900's, East Haven's law and order was basically controlled by a sherrif in nearby New Haven. However, in the early 1900's, when East Haven was growing and becoming more independent, law and order was needed on a local level. Thus volunteers helped maintain order in the town, they were known as Constables. As an awareness became apparent to the townspeople towards the necessity of Constables, the town board headed by Edgar Bacon and John Howe (1st Selectman) set forth the means by which Constables could be selected. Each political party would submit four names, and of this total, 7 were selected. Jim Smith was one of the first constables. He owned a small farm on Main Street, now the corner at Main and Hemingway. His barn served as a temporary jail for an occasional drunk. As quoted by Hans Hansen, Jr., "Jim Smith, lead constable, was always standing on the corner ready to pinch everyone he had a chance to". These early constables received minimal, if not non-existant, pay for their services. The earliest available pay records were:

Other records are as illustrated from 1924, page 17 of the Town Pay Records, also 1925, page 26 and 27.

Aside from the pay itself, is a consistancy in the records of allotted monies being largely returned as unused funds.

"Those who were liable to live on the new side of the river had only to cross the bridge in order to be out of reach of the city police. Although the town of East Haven maintained its full compliment of town officers, it had no permanent police having power to make arrests for disturbance of the peace, and no place when persons arrested could be detained for trial. The necessity for which a place was cautioned against causing a petition, had previously been presented to the town paying that such might be made as would merit. The people of Fair Haven felt that they ought to have more effectual protection then they had especially as the state of society thus from causes already mentioned was growing more every succeeding year. Nothing however was done in regard to the matter till the present year when the petition being renewed at the annual town meeting a large number of special constables were appointed and the Selectmen were authorized and directed to 'provide a suitable place for a small stone lock-up' was erected on the wharf south of the Bridge amply commodious, as may be hoped for all the necessities of the town in that direction. That there was any necessity at all for such an expedient would seem to indicate a deteriating of public morals in the town and an increasing disregard of social order."

EHPD STARTS

As East Haven progressed in its evolution, the "Police Department" became more of an actuality. In March, 1925, under the regime of First Selectman, Robert H. Gerrish, a bill was passed forming a Board of Public Safety of East Haven with jurisdiction over the Fire Department and Police Department.

The Police Department's first chief was Hugh Farrell, a genial, if quiet man, with a good reputation throughout the state.

His "force" was one patrolman, shortly afterward increasing 100% with the addition of a second patrolman. The Assistant Chief was Wesley Stepp, a "really good cop", frequently remembered for the time he captured a burgular breaking into a former A&P store in the center of town. The burgular swung at the then patrolman with an iron bar, knocking his front teeth out. Stepp then grabbed the bar and returned the compliment, and they both ended up at the station house, somewhat worn out. Stepp drove the first East Haven Police vehicle, a motorcycle. This is apparent in this 1928 group photo, by his trousers. Also depicted is that he was the only one at this time apparently carrying a gun.

Soon after this formation, the townsfathers planned to build a Town Hall large enough to incorporate a Police Department. Thus in 1928, after the Town Hall was complete, the Police Department was officially and physically apparent, consisting of approximately eleven members.

EVOLUTION

As time progressed, the EHPD grew and advanced into a modern day crime force. The station house at the Town Hall became increasingly too small for the needs of the Department.

In October, 1973 a new facility was built on the east side of
North High Street - just north of Gloria Place. This modern
complex combined (upper level) a control center, briefing room,
male and female lockups, booking area, detective area, records
section, police commissioners meeting room, offices for the
Chief and inspectors, officers, sargents, and a combined
patrolmen report room, lounge, maximum security prisoner
convenience port. On the lower level: locker room and shower
facilities, gun range, auxiliary police meeting room, photography
lab, exercise room and miscellaneous custodian quarters.

PATROL

Todays Patrol function is very streamline and up to date.

The modern control center processes and records all

complaints and problems set forth by the town.

The Town is broken down into 4 sections of patrol:

- A North Foxon
- B Lower Foxon
- C Center
- D Shore

The three squads patrol East Haven during three shift times:

Squad A - Midnight - 0800

Squad B - 0800 - 1600

Squad C - 1600 - Midnight

Squad members work 4 days on and 2 days off. This is offset by having different days assigned to different individuals.

Patrolmen carry S&W .357 model 65 revolvers with .38 cal. SP&P hollow jacketed ammunition.

The main patrol vehicle is a 1981 Ford LTD equipped with overdrive, protection cage, band radio, overhead lights, and PA system.

Standard equipment in the trunk is a fire extinguisher, oxygen unit, CPR masks, flares, measuring tape, first aid kit, and blanket.

Other vehicles used by the East Haven Police Department are: 2 motorcycle units (presently out of service), paddy wagon, 3-wheeler and crime prevention van.

AUXILIARIES -

There are 28 active members of the E.H. Auxiliary Police with George Moncingilo as President. They have weekly Monday meetings and support the regulars at weekends and during special events by their assistance as riders and by operating their own patrol car #10.

POLICE COMMISSIONERS -

The E.H. Police Commissioners are an appointed group that meets monthly to make important decisions concerning the Department and relations to the community. They are common working people of the community with a more than common interest in their community.

SUPERNUMERIES -

In 1928 there were 7 supernumeries. This group served on auxiliary type function, but more on a professional type basis. However, over the years, the number dwindled and is now down to one. This function now is seldom, if ever, used.

DISPATCHERS -

The department utilizes a Civilian dispatcher (Bob Neal) or 5 or 6 different trained auxiliary officers when needed.

Usually squad members perform this function.

HISTORICAL SOCIETY

The Historical Society was started in 1969 for the purpose of preserving East Haven historical artifacts, but especially old buildings.




Direct from the charter are the following objectives: "Cbjectives: Two fold":

EAST HAVEN POLICE DEPT. 1928






Police Commission

The Board of Police Commissioners met on the last Tuesday of the month during fiscal 1970-71. The Commission created and filled the position of Deputy Inspector and participated in contract negotiations. Installation of a system to record incoming calls and a system to record on-the-scene reports from patrolmen was accomplished.

The Commission was instrumental also in installing a traffic light at the Firehouse on Route 80 enabling fire trucks to exit and enter more safely.





Makes First Appearance

East Haven's Official Seal Bears Davenport Likeness



This is the new seal for the town of East Haven. Shown on it is John Davenport, one of the leaders in the founding of New Haven Colony. EAST HAVEN — First Selectman Dominick H. Ferrara announced that a new official seal is to be used by the town of East Haven. The first selectman said that he approached the Board of Selectmen about eightmonths ago suggesting that a seal with more meaning than the old ones be selected.


He explained that the official seals of the town to date have not had any historical significance. Usually the seals just indicated that it was the town of East Haven.

The new seal, which appears on Police Manual, bears a likeness of John Davenport who figured prominetly in the history of the area.

Research showed that the New Haven Colony, under the Rev. John Davenport and Theophilus Eaton was considered among the most learned and wealthiest of all the companies which came to New England, Mr. Davenport was head of the company although Mr. Eaton was named the governor. He was a leader of the colonists who came from England on the little ship, Hector, to the shores of the Quinniplac River on April 13, 1658. Together in the name of the colonists they purchased the land presently occupied by the towns of New Haven, East Haven. Branford, West Haven and Orange, and extending north as far as parts of Meriden and Prospect from the Indian Chief Momauguin, his sister Shaumpischu and the Sachem Montowese.

The Rev. Mr. Davenport was the first minister of the Church at New Haven, which for many years after included those who came to live in the section inow designated as East Haven. He was also one of the "Seven Pillars" of the Colony, This was the governing group which was organized Oct. 25, 1639.

A native of Conventry, England in Oxford, and for a time was minister of St. Stephen's Coleman Street Church in London. There he disagreed with Bishop Laud and sought refuge with some of his parishioners in Amsterdam, Holland. It was from that city that the group came to New England as Puritan discenters. He left New Haven in 1668 and moved to Boston where he died two years later.


The Police Department has seen a continuing increase in all phases of its work during the past years with this last year proving no exception. The total arrests for the year were 999 over last year's figure of 831. The majority of these were motor vehicle violations numbering 441. The second highest number of arrests were for brach of the peace totaling 124. The number of complaints investigated not necessarily resulting in charges were 4,434.

Medical assistance calls handled by the Department last year were 502. This reflects services such as transportation to hospitals or doctors by ambulance or squad car.

The Detective Division of the Department also reflects the increasing volume of work. The total arrests made in this division was 266 over the previous year which was 226. The highest percentage of arrests for any single charge was 53 for narcotics representing approximately 25%. The next most numerous charge was theft numbering 35.

The increase in all phases of work was stable with the exception of referrals to Juvenile Authorities which jumped alarmingly from 26 in 1969-70 to 115 in 1970-71.
